**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**OPEN ONLY TO LEGAL RESIDENTS OF: THE 50 UNITED STATES (EXCLUDING RESIDENTS OF FLORIDA AND NEW YORK) AND THE DISTRICT OF COLUMBIA, AGE 21 OR OLDER, and (ii) CANADA (excluding Quebec) WHO AT THE TIME OF ENTRY HAVE REACHED THE LEGAL AGE OF MAJORITY IN THEIR PROVINCE/TERRITORY OF RESIDENCE. VOID WHERE PROHIBITED.**

**1. HOW TO ENTER:** The entry period for the Alaska Cruise and Travel Show Sweepstakes (the “Sweepstakes”), sponsored by Holland America Line N.V. (“Sponsor”), begins at 12:01:00 am Pacific Time (“PT”) on January 15, 2025, and ends the earlier of 3:30 pm PT on March 15, 2025 *or* when the Event (defined below) capacity is reached (the “Entry Period”). Maximum capacity is approximately 6,000.

To enter, during the Entry Period, Eligible Entrants (defined below) may enter by: (i) registering for the Holland America Line Alaska Cruise and Travel Show event, scheduled to take place on March 15, 2025 from 9:00 am until 4:00 pm PT, at the Vancouver Convention Centre, 999 Canada Place, Vancouver, British Columbia, Canada V6C 3C1 (the “Event”) and (ii) having a verified attendance at the Event (via check in). Registration can be completed in advance at [www.alaskatravelshow.com/vancouver](http://www.alaskatravelshow.com/vancouver) (the “Website”) beginning January 15, 2025, or on-site at check-in Event on the day of the Event. By completing a registration and attending the Event in person, an Eligible Entrant will receive one (1) entry in the Sweepstakes. Individual must ensure the QR code on their Event ticket is scanned upon entry into the Event *or* that they are manually checked in at the check in counter by name and email address in order to ensure that their attendance is confirmed. If for any reason an individual enters and attends the Event without their QR code being scanned or having their registration manually checked in, they will not receive an entry into the Sweepstakes. If for any reason upon entry into the Event, the Event personnel do not scan an entrant’s ticket/QR code or manually check in the entrant’s registration, entrant can (immediately) visit the Event registration desk and ask for their QR code tickets to be scanned or have their registration looked up and manually checked in for admission (and therefore entry, so long as the Entry Period is still open) prior to the conclusion of the Event. Event capacity is limited. There is no cost to register for or attend the Event. Limit: one (1) entry per person/email address throughout the Entry Period. Proof of registering or attending the Event does not constitute proof of entry into the Sweepstakes. Entry times will be determined using Sponsor’s computer, which will be the official clock for the Sweepstakes. **No purchase or payment of any kind is necessary to enter or win the Sweepstakes.**

**2. ELIGIBILITY:** The Sweepstakes is open only to individual persons who as of the date of entry are:

(i) legal residents of the United States (excluding Florida and New York) or the District of Columbia and are 21 years of age or older; and, (ii) legal residents of Canada (excluding Quebec) who have reached the legal age of majority in their province/territory of residence and are located in Canada (excluding Quebec) as of the date of entry (“Entrants” or “Eligible Entrants”). Entrants may be required to show proof of eligibility. Employees of Holland America Line N.V. (“Sponsor”), its parent companies, subsidiaries, affiliates, distributors, and advertising and promotion agencies (all of the foregoing, the “Sweepstakes Entities”), and such employees’ immediate family and household members, are not eligible to enter or win. Void in Florida, New York, Quebec, U.S. territories, outside the U.S., and where prohibited by law. In the event of a dispute regarding an entry associated with an online registration, such registration will be deemed made by the authorized account holder of the e-mail address submitted at the time of registration (i.e., the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address). Sponsor’s decision is final in deciding the identity of an entrant.

3. **WINNER SELECTION:** During the Event, Sponsor or its agent or representative (the “Presenter”) will randomly select one (1) entry (a “Potential Winner”) from among all eligible entries received as of the time of the drawing. There will be a total of seven (7) drawings conducted at various times during the Event (the “Drawing(s)”). Entrants do not need to be present at the time of the Drawing in order to be eligible to win. Odds of winning depend on the total number of eligible entries received up to the point/time of drawing. Non-winning entries from one drawing will roll over to subsequent Drawings (if any) along with all new entries received since point of last Drawing, but once an entry is pulled as a Potential Winner, it will not be included in subsequent Drawings.

4. **PRIZE CLAIM CONDITIONS:** The Potential Winners will be announced during the Event on March 23, 2025 and will also subsequently be notified by e-mail at the email address provided at time of registration (“Winner Notification”). Before being declared an official “Winner,” all Potential Winners are subject to verification and will be required, within ten (10) days of the send date on the Winner Notification, to: (a) correctly answer a mathematical skill-testing question without mechanical or other aid (which may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, by telephone, or in the Sponsor’s release); and (b) complete and sign an Affidavit of Eligibility and Publicity/Liability Release, which among other things, releases the Sweepstakes Entities from any liability in connection with this Sweepstakes or the use, misuse, awarding or possession of any prize and all information required for tax reporting, as applicable, in order to claim his/her Prize. If a Potential Winner fails to complete, sign and return to Sponsor the Affidavit of Eligibility and Publicity/Liability Release (where permitted by law) or fails to correctly answer the skill-testing question within the required time period, or if any attempted notification or prize delivery is returned as undeliverable, if the Potential Winner refuses to accept the prize as awarded, or if Sponsor determines that a Potential Winner fails to meet the eligibility requirements or is otherwise not in compliance with these Official Rules, the Potential Winner may be disqualified and an alternate Potential Winner may be selected, in Sponsor’s sole discretion. Once verified, a Potential Winner will be referred to as a “Winner.”

Guests of Winners may also be required to sign an Affidavit/Release prior to ticketing and within time frame specified by Sponsor. Each Potential Winner must comply with all terms and

conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. All prizes claimed will be awarded. Unclaimed prizes may not be awarded.

5. **PRIZES:** A total of seven (7) prizes are available to be won, as follows:
- The Winners from the first six (6) Drawings selected at the Event will be the first place Winners and will each receive one (1) \$500 USD Holland America Line gift card. Gift cards are subject to the terms, restrictions, and conditions as set forth thereon.
  - The Winner from the seventh and final Drawing at the Event will be the grand prize winner and will be awarded one (1) seven- (7) day Holland America Line Alaska cruise for such Winner and one (1) guest round-trip from Seattle, WA or Vancouver B.C, in May, June, August, or September 2025 (“Cruise”). Cruise Prize is subject to availability and there is no guarantee that a Cruise Winner will receive their first choice Cruise, and such Winner waives all liability related to not receiving their first choice. Cruise Prize is inclusive of taxes, fees, & port expenses. Approximate Retail Value (“ARV”) of Cruise Prize \$3,998 USD/\$5628 CAD.

Winner of Cruise must travel together with his/her guest on the same itinerary. Cruise Prize consists of stateroom accommodations for the Winner and one (1) guest, sharing accommodations of one stateroom. The stateroom will be assigned by Sponsor, in Sponsor’s sole discretion. All expenses and costs associated with the acceptance or use of the Cruise Prize that are not expressly specified in these Official Rules as being part of a Prize (including without limitation airfare or other transportation to or from cruise ship/point of embarkation/disembarkation, hotel accommodations, shore excursions, travel insurance, laundry service, spa treatments, alcoholic beverages, alternative dining options, local and long distance telephone calls, ship to shore communications including Internet usage, merchandise and souvenirs, incidental expenses, tips and gratuities, medical insurance, COVID-19 test expenses, personal onboard expenses and applicable passport, visa and entry/exit fees) are the responsibility of the Winner and guest.

All reservations and Cruise arrangements including, without limitation, the dates and times, are subject to availability (as determined solely by Sponsor), and restrictions such as blackout dates including holidays may apply. **WINNER MUST CRUISE IN MAY, JUNE, AUGUST, OR SEPTEMBER OF 2025; no alternate cruise dates are available.** If for any reason a Winner cannot travel and/or cruise in the dates specified, such Winner shall forfeit the Prize and no replacement prize will be awarded. Sponsor reserves the right to refuse to embark any Winner or guest, at any time if, in the sole opinion of Sponsor, a Winner or guest is unfit for any reason for the cruise. Sponsor and all other Released Parties (defined below) shall not be responsible for any cancellations, delays, diversions or substitution or any acts or omissions whatsoever by cruise operators or any other persons providing any prize-related services or accommodations. Without limiting the foregoing, the Sponsor and all other Released Parties will not be in any way responsible (and for greater certainty, are not obligated to offer any substitute prizing) in the event that any part of the Prize is delayed, postponed, re-scheduled or cancelled for any reason whatsoever (including, without limitation, due to illness or health risks, or any governmental or health authority orders, measures, directives or guidance in response to such illness or risks, such as, without limitation, those that may be implemented to mitigate COVID-19 transmission, or due to any other cause of any kind or nature whatsoever). Winner and guest are also responsible for obtaining travel insurance (and all other forms of insurance) at their option and hereby

acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance. Lost, stolen or damaged cruise tickets or gift cards will not be replaced or exchanged.

Cruise value cannot be used as partial payment toward a different Holland America Line cruise, cruisetour or stateroom category other than that assigned, or used in conjunction with any other offer or promotion. Winner and guest are NOT eligible for Holland America Line air/sea programs or Holland America Line's Cancellation Protection Plan program.

Winners must confirm with Sponsor their intent to travel on the cruise Prize at least 60 days prior to the departure of such cruise and all cruises must be booked at least 45 days prior to the departure of such cruise. If Winner's guest is: (i) a legal resident of the United States (excluding Florida and New York) or the District of Columbia and under the age of 21; or, (ii) a legal resident of Canada (excluding Quebec) and has not reached the legal age of majority in their province/territory of residence, he or she must be accompanied a parent, guardian or chaperone that is at least 21 years old and responsible for their care during the cruise. Sponsor will not be responsible if Winner/guest are denied entry onto ship, into various ports during the cruise, or return entry into departure point. In such a situation, the Winner/guest will be responsible for any and all additional costs incurred. Prize elements may not be separated. Prizes will be awarded provided each is validly claimed by the date specified in the Prize award notification. General Prize Details (applicable to all Prizes): Maximum total ARV of all Prizes in the Sweepstakes: \$6,998 USD/\$9,851 CAD. Canadian ARVs are based on the conversion rate as of December 3, 2024 and the difference in value, if any, at time of prize award shall not be awarded.

Prizes are non-transferable, non-refundable, non-negotiable for cash, and may not be resold. No substitution of a Prize or any component thereof is permitted, except in the discretion of Sponsor, which reserves the right to substitute a Prize or Prize component of equal or greater value for any reason (including without limitation if the fulfilment of the Prize, or any part thereof, is rendered

The Released Parties are not responsible for, and will have no liability for, undeliverable e-mails resulting from any form of active or passive e-mail filtering by a user's Internet service provider and/or e-mail client or for insufficient space in user's e-mail account to receive e-mail. The Released Parties are not responsible for, and will have no liability for, any damage to any computer or computer system resulting from participation in or accessing or downloading information in connection with this Sweepstakes. The Released Parties are not responsible for, and will have no liability for, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause any postponement or cancellation of any prize component or event. By entering the Sweepstakes, each Entrant consents to the collection and use of their personal data as permitted pursuant to the privacy notice and this Section 9 (and in the event of any conflict, the privacy notice shall prevail).

**10. DISPUTES:** Except where prohibited by law, by entering the Sweepstakes, each entrant agrees that:
